WELCOME to the first edition of the North American Animal Liberation Front Supporters Group (N.A.-A.L.F.S.G.). newsletter, *Underground*!

**DISCLAIMER**: The information in *Underground* is not intended to encourage or discourage anyone to do anything illegal; it is for entertainment only. Material within *Underground* is not necessarily that of the A.L.F. or the North American A.L.F.S.G.

We have received several letters recently asking what has happened to the A.L.F.S.G.-Canada publication, *Combat*, which last came out in 1992. And also several letters saying "you never responded to my last letter".

The last two years have been very difficult. Since June 1992, our good friend and comrade Darren Thurston has been fighting a terrible legal battle, mostly from behind bars, for charges stemming from A.L.F. actions in Edmonton, the home of the old A.L.F.S.G.

In addition, state harassment of the animal rights movement in the USA has increased dramatically. Several people have been imprisoned for refusing to testify before Grand Juries, and we have watched our brother Rod Coronado ruthlessly hunted by the F.B.I. It is a testimony to Rod's courage that he remains outside the grasp of the police.

It is sometimes hard to remember, when watching your friends go through hell, what this movement is about: liberation.

Given the obvious need for an active A.L.F.S.G. that could support animal liberation prisoners in Canada <u>and</u> the USA, the old A.L.F.S.G.-Canada ended and the North American A.L.F.S.G. was born.

Of course we are not here only to support our human friends who are caged, but to do what we can to assist the Animal Liberation Front in freeing our animal friends from the cages of the animal abuse industries.

We have recently completed the process of moving from Edmonton to Victoria, B.C. and have almost finished sifting through the huge stack of mail. So please be patient with us for a short while longer! We are making efforts to ensure that your letters are answered quickly.

What we need now, more than your patience, is your generosity. We are, at present, unable to mail to the S.G.'s full membership and cover the costs of jail support. This puts us in the frustrating position of having to choose whether to limit our work to provide an educational/communication forum for the A.L.F. and its supporters, or to limit our assistance to animal rights prisoners.

We are dealing with the lack of funds by limiting our mailouts. The N.A.-A.L.F.S.G. has a huge mailing list, and to mail every update or newsletter to our 1000+ supporters is, at this point, impossible.

Because the A.L.F. is a movement that must survive underground, communication between active cells, and between activists and supporters, is almost impossible. It is easy for people who are taking direct action on behalf of the animals to feel as if they are the only ones. Supporters of the A.L.F. sometimes feel that the Front has withered away because they do not hear of any actions.

In the face of the state's attempt to destroy the animal liberation movement, it is crucial, now more than ever, to communicate with each other and support each other. Running the N.A.-A.L.F.S.G. is hard work but it is worth it every time we get a report of animals freed or economic damage done to animal abusers. We all need to know that there are people out there who are translating their caring for animals into successful actions, that as individuals we can make a difference.

We have been touched by the generosity of you, the A.L.F. supporters, in recent months. We ask once again that you continue to give what you can, so that we can do our job more fully.

MAIL SECURITY

If you are a member of an active cell, send any clippings, or your own report, with date, time, place, and a few details about the action. Send your reports on plain paper, using block capital letters, or a public typewriter that many people have access to. Wear gloves at all times so your fingerprints are not on the paper, envelope, or stamp. Do not give your address, and don't lick the stamp or envelope -- wet it with a sponge. Remember you should expect that all of our mail and any other support groups' mail is opened and read by the authorities. Do not tell us about upcoming actions.

#### ANIMAL LIBERATION FRONT (A.L.F.) GUIDE-LINES:

The Animal Liberation Front carries out direct action against animal abuse in the form of rescuing animals and causing financial loss to animal exploiters, usually through the damage and destruction of property.

The A.L.F.'s short term aim is to save as many animals as possible and directly disrupt the practice of animal abuse. Their long term aim is to end all animal suffering by forcing animal abuse companies out of business.

It is a nonviolent campaign, activists taking all precautions not to harm any animal (human or otherwise).

Because A.L.F. actions are against the law, activists work anonymously, either in small groups or individually, and do not have any centralized organization or coordination.

Any group of people who are vegetarians or vegans and who carry out actions according to A.L.F. guidelines have the right to regard themselves as part of the A.L.F.

#### ANIMAL LIBERATION FRONT SUPPORTERS GROUP GUIDELINES:

The purpose of the Supporters Group is to support the work of the Animal Liberation Front by ALL LAWFUL MEANS POSSIBLE. This includes:

- \* support of imprisoned activists
- \* support and defense of the A.L.F.
- \* educating the public as to the need and rationale of direct action
- \* providing a communication forum through the Supporters Group newsletter
- \* raising funds for all the above activities

The Supporters Group is for those who wish to support the A.L.F. without breaking the law. We encourage the participation of all activists — including those who are unable to, or who do not wish to, take part in direct action.

The Animal Liberation Front consists of small autonomous groups of people all over the world who carry out direct action according to the A.L.F. guidelines. You cannot become a member of the A.L.F. — or an A.L.F. activist — through the North American A.L.F. Supporters Group, which is a completely separate organization.

### PRISONER NEWS

#### NORTH AMERICAN PRISONERS

Kim Trimiew, Spokane County Jail, 1100 West Mallon, Spokane, WA 99260 USA

Kim has been in prison since February for refusing to testify before a Grand Jury in Washington. Previous prisoners have spent 158 and 159 days for refusing to testify; Kim reached day 153 as of July 19. For news on Deb Stout, who was also in the Spokey Pokey, see p. 9.

David Barbarash, Edmonton Remand Centre, 9660 - 104 Ave, Edmonton, AB, T5H 4B5, Canada

David is awaiting trial on charges related to a 1992 A.L.F. raid on the University of Alberta which resulted in the liberation of 29 cats and significant damage to the laboratories. David was arrested in California in May and deported at the beginning of June. He has been refused bail several times and will most likely be held in the ERC until his trial. His preliminary hearing is scheduled for August 31.

Darren Thurston, Fort Saskatchewan Correctional Facility, Bag 10, 7802-101 st, Fort. Sask., AB, T8L 2P3, Canada Darren is serving a two year sentence for charges relating to a 1992 raid on the University of Alberta (29 cats were liberated and the lab trashed) and the burning and spraypainting of lobster trucks in 1991. Darren was arrested in 1992 and served 14 1/2 months while awaiting trial. Darren was tried in 1993 and received time served and an order to pay \$75,000 in restitution. In March 1994 the Crown appealed the sentence and asked for three more years; in May the Alberta Court of Appeal sentenced Darren to two more years less a day.

[NOTE: Darren has applied to be transferred to Fort Saskatchewan and is expecting to move there some time in August. His mail will be forwarded there. Also, please do NOT put any stickers on his letters or envelopes.]

On Friday June 3, Gurjett Aujla was arrested at his home. He was questioned over the weekend and was then formally charged with "Conspiracy to cause explosions" on June 6. He was remanded for a week to HMP Birmingham and according to the UK-ALFSG "it is expected that he will remain there for some time".

Although Mark is not an animal rights prisoner per se, his actions to prevent wilderness destruction (and wildlife habitat) deserve support and we would encourage people to consider Mark as part of our extended movement.

Thurston is serving a 2 year sentence for this & other actions.

Although I had a Canada-wide warrant for my arrest for two years, I was never served it by the RCMP. My capture in California on May 9th was a result of FBI and local police surveillance on several homes, and was carried out with a show of extreme force. I am thought to be such a dangerous person that every one of the two dozen or so cops they apparently needed at the roadblock had their guns out and pointed at myself and a friend. I don't knowifit's all the years of media desensitization, but I wasn't really scared;

of my beliefs "frightening", and believes I pose a "danger to the public". Whatever. Let them play their little power games. They have my physical body for this relatively short period of time. They will never have my spirit, or my mind, or my will. And that's where the real power lies. It doesn't matter whether I'm innocent or guilty; I'm happy the cats are free to live out their lives in peace.

Recently I read a report in a "Security" magazine which states that the ALF are reported to be active now in 45 countries! Actions continue in spite of police crackdowns everywhere, includ-



## GRAND JURIES AND THE

(Author's note: This is an update of a story written in 1991 after federal grand juries in northern California crippled progressive activist groups in that area. That article cautioned that activists were not taking the grand jury threat seriously, and because of that, the government's use of grand juries would expand, further disrupting the animal liberation cause. The prophecy has come true. Today, there are six sitting grand juries.)





que, New Mexico; New Orleans, Louisiana; Salt Lake City, Utah. A Eugene, Oregon U.S. panel, begun in 1991, reportedly ended last year and a series of three grand juries in Sacramento, California, ended in 1991 after nearly four years of intimidation and abuse.

We caution that because of the ultra-secret nature of federal grand juries there could be more grand juries at work.

At least four good activists have been jailed for up to 159 days by the newest of these grand juries, and the government continues to gather information, intimidate activists, their families, support networks and others associated with the liberation of animals and the planet.

The federal grand jury in Spokane has incarcerated activists Jonathan Paul (158 days) and Rik Scarce (159 days). Kim Trimiew has been jailed since Feb. 18, 1994: Deb Stout, who was jailed on Feb. 18 as well, was released only days ago, on July 19. Henry Hutto was the first activist to successfully resist the grand jury when he spent 45 days in jail in Sacramento in 1990.

Equally disturbing is that the government, and the powerful corporate entities it represents, is, unfortunately, obtaining what it really wanted all along--INFOR-MATION ABOUT THE STRUCTURE AND WORK-

otherwise: the repressive and illegal use, under the direction of the U.S. Justice Department, of federal grand juries against animal liberation and environmental activists has severely disrupted these social justice movements since 1990.

It serves no useful purpose--in fact it hurts the cause-to ignore the threat, or the reality. But, to face it is to be able to deal with it in a rational, and political sense. To understand the threat, and power, of grand juries is to empower yourself.


And, if you can become empowered, you will not feel fear. And, without fear, the state, and the abusive grand jury system, cannot do anything to you.

The good news is that once we face this fact, and become more familiar with the grand jury and its abuses, we can resist the unconstitutional use of these undemocratic tribunals. We can even turn the power of the government back against itself. The "Lexington Six", an antiwar group jailed for non-collaboration with a grand jury decades ago, said it best:

"People must mobilize around these issues. To do this, people must first become familiar with the grand jury and its abuses, publicizing the facts and educating others as to their rights. Secondly it is important to engender in others a commitment to the resistance of these abuses including, but not limited to one's refusal to testify before the grand jury. Thirdly, it is necessary to keep in mind that while court battles can be fought and sometimes won, these abuses of the law are not abnormalities in a basically good system-they rather illustrate the true intentions of a BAD system more openly and graphically than other more insidious practices (and) this should dominate our thinking as we organize."

We are now experiencing the most intensive use of the illegal authority of grand juries since the repression against the peace and civil rights movements of the 1960s

#### INGS OF THE GRASSROOTS MOVEMENT.

There is some recent good news. The Portland grand jury hs yet to hear (to our knowledge) any testimony (since January). Its most recent attempt to harass activist Beth Fries (June 28) failed when a motion to quash was filed by her attorney. And, because of the motion, two other potential witnesses (parents of an activist) were able to avoid grand jury testimony.

And, in Albuquerque, where there is a new grand jury, only one of three activists actually went into the grand jury room. The two others, after motions were filed to quash their subpoenas, were excused, and must be resubpoenaed.

However, too many activists have collaborated with the state, and too many activists have become informants, some unwittingly and others knowingly, to "save" themselves. But, if activists know their rights, they can protect them--and those of others.

There is no doubt the FBI, ATF and Justice Department have abused the legal system, and under the guise

of attacking "terrorism," have become the real terrorists by harassing people because of their



political views and beliefs.

The grand jury is being used by the government as an instrument of political repression because it does, in fact, frighten many activists, forcing them out of a political movement and

causes others to inform on their former friends and activists out of fear.

In California, where the first federal grand juries were held in the late 1980s and early 1990s, activists-turned informants--attempted to justify turning over activists' names, addresses and phone numbers--in addition to possibly incriminating information.

To make matters worse, other activists, instead of acknowledging the ethical wrongs of the informants, embraced them, inviting them back into the movement. This is how things can go wrong, very wrong, if we are not prepared to resist.

If any of this sounds familiar, it is because the tactic of "isolating hardcore activists (read committed)" from the

rest of the movement is EXACTLY what was proposed in the American Medical Association's "battle plan" against the animal rights movement in 1989. Interestingly enough, the AMA also called for Justice Dept. intervention, which is what has happened.

As the National Lawyer Guild's primer on grand juries says, "For many political activsts, the historic and principled way to avoid these dilemmas (informing, perjury) has been the invocation of absolute noncollaboration with grand jury investigations of political movements. While this has resulted in many instances with the witness' incarceration for contempt, it has also discouraged the subpoenaing of further witnesses, and on some occasions, the withdrawal of all subpoenas."

Remember that you have no right to remain silent in a grand jury room. That is why you need assistance before your appearance. Following are some other thoughts, and examples, to ponder:

1. The goal of grand juries is to terrorize, not investigate crimes. Period. When you hear, from agents, lawyers, or other activists, that a grand jury has been empaneled to "investigate" this crime or another, DO NOT BELIEVE IT. The goal of the government, as has been documented in dozens of grand juries from movements past, is to intimidate, disrupt and, if they can,

destroy movements. This is the truth and this is what you should tell the media and others who ask. It is the government's claim they are investigating a crime--that is their excuse for trampling our rights. DO NOT BUY



INTO THE STATE'S RATIONALE. We know their true intent--to harass activists, and gain information about



individuals and political organizations. That, by the way, is illegal and unconstitutional. By the way, it is dangerous to talk freely about why you think, or someone else thinks, a grand jury has been started. EXAMPLE: In California, activists and the media were told the grand jury was investigating a research lab fire. In truth, the questions asked were about groups and activists in general, even those in other states. Also, in Albuquerque,

everyone "heard" the state was investigating power line disruptions. However, the questions dealt with activists' political association, not alleged crimes.

2. You do not have to talk to the FBI or other agents. However, it is a crime to lie to them. The best response is no response. Contact a lawyer and your defense team (see below). EXAMPLE: Recently, some activists were located, and served subpoenas and now face jail time, because grassroots groups

accordingly.

4. There is no such thing as a "innocent" question. EXAMPLE: The Leslie Bacon Case. The National Lawyers Guild, which has produced a wealth of information about grand juries, cites the Leslie Bacon case. Leslie was an antiwar activist who agreed to appear before a grand jury that was allegedly investigating a bombing in the U.S. capitol. Since she knew nothing about it, Leslie decided to go to the grand jury room alone. As it turned out, the gov-

yers, who we hire to defend our rights. The committee will discuss issues like how to coordinate media, demonstrations, what legal strategies to take and what legal motions to file. EXAMPLE: In several cases, good activists, after hiring lawyers, shunned help from other activists and legal workers, and instead followed the guidance of their lawyers, which has not been in the best interest of the cause. This results in a lack of coordinated strategy to end grand juries, and the threat to political freedom. It may help save the individual

activist, but even that is debatable (see Leslie Bacon Case). It also isolates activists, when we should be pulling closer together.

6. Share information, community unity. The government's goal is to obtain information. So should ours. The more information we have as a movement about the actions of a grand jury the better prepared we are to resist abusive actions. All legal motions, among other information, should be shared between movement lawyers

and defense committees. To do so facilitates trust during a difficult time, and also makes it easier for one legal team to pick up on a good legal strategy used by another legal team. EXAMPLE: In practice, there has been little sharing of information between lawyers in our movements (and then only when pressed by the activist clients). In the California cases, the grand jury had been going on for months, but activists who had been subpoenaed did not inform other activists. If there had been more advance warning, maybe no one would have been jailed, and maybe the current grand jury on slaught could have been avoided.

7. Resist attempts to intimidate you. Make the government do its job. Use every legal means to resist the illegal and abusive actions of a federal grand jury. EXAMPLE: As opposed to the Albuquerque case where activists filed motions to quash, and were re-



and individuals willingly, and without subpoena, gave the FBI the activists' new address. Remember, you don't have to answer your door, and law enforcement cannot enter unless they have a warrant. Just keep the door closed until you know who's on the other side.

Do not believe ANYTHING the government says. A typical FBI/ ATF comment goes something like, "We already know everything, we just want you to confirm it." Gee, if they already knew everything (whatever that might be), why do they need it confirmed? In fact, they DO NOT have anything; that's why they've come to see you. And, they're acting on illegally obtained information (wiretap or rumor/innuendo from another activist) that is not admissible in court. Act accordingly. And, if they say you are, or are not, a target, don't believe them! Their job is to lie. and to say whatever they think will scare you into cooperating. Again, act

ernment was really interested in other individuals and other activities, not at all connected to any bombing. By answering one question, Leslie was had. She, and others, later were indicted anyway. The lessons learned include (a) the government was much more intersted in pumping Leslie for information about friends than the so-called bombing plot; (b) her case shows how easy it is to waive what rights you may have by answering a single question; (c) Leslie learned that testifying doesn't mean you'll save your own skin; and (d) this is the most important: as a result of her testimony, new grand juries were begun in three other cities, and many other people were harassed.

5. Form a defense committee. If you are subpoenaed, or think you will be, form a defense committee with friends, witnesses, legal workers. As activists, we determine the correct strategy for the liberationist cause, not law-

leased from having to appear, a California organization recently made the mistake of turning over records about certain individuals to the government rather than fight a subpoena. The group could have delayed, and possibly even had the subpoena quashed (withdrawn) if they had taken some basic steps to protect their rights, and everyone else's. Of course, don't break the law by obstructing a grand jury, or avoiding a subpoena. There are legal ways to fight these terrorist-like attempts to repress our rights.

- Avoid the temptation to "just get it over with." The Lawyers Guild rightly suggests that activists, and lawyers, should avoid the temptation to "just get it over with," by either testifying, or even going to jail, without first exhausting legal and constitutional remedies. EXAMPLE: While it is honorable to go to jail rather than cooperate, it can still have a negative impact because the government (in the Spokane grand juries) uses the jailing of activists as an example to others to "cooperate." It is important to resist as long as possible. To do so uses up the government resources so that they have less time to harass other activists.
- 9. What happens if you testify? First of all, you have made real what they were only guessing, you have increased your chances of being subpoenaed again and you may be responsible for someone, perhaps even yourself, for going to prison, maybe for something they didn't do. Because, in a grand jury proceeding, people can be indicted on hearsay (rumours) and innuendo.
- 10. Do not be afraid. Easy to say, but it is also practical. EXAMPLE: An activist subpoened in California in 1990 showed no fear, and even refused to show up at the grand jury, opting instead to read a statement defying the grand jury. She was never bothered again. Likewise, activists in California who cooperated were harassed repeatedly. Remember: the state feeds on fear. Do not show fear, and you'll starve the monster.

11. If you go in alone: The Jonathan Paul Case. In the case of Jonathan Paul, an activist who eventually spent 158 days behind bars for not cooperating with the Spokane Grand Jury, you can see why no one should go to a grand jury alone. He decided. because like Leslie Bacon he had "nothing to hide," to go into the grand jury room by himself. The result was hours of prosecutorial harassment, questions about everything from his family to his girlfriends, and then his jailing (all in the same day!) when he refused to answer questions about other activists and his political activities. He wasn't even allowed a postponement to obtain an attorney. The lesson learned is that although you have few rights in the grand jury room, a good activist lawyer and a faithful support team can make it easier for you.

[Jonathan Paul, Henry Hutto and Crescenzo Vellucci, all jailed as a result of grand jury harassment, helped form the National Activist Network's Grand Jury Project. It provides free information (gleaned from several years of research about grand juries and other movements), legal assistance and lawyer referrals to all grassroots activists threatened by grand juries, and associated government harassment. The following list of actions is printed as received.

The following is an Action Report listing the activities of the Animal Liberation Front, Southland Unit, which operates in Southern California. The ensuing actions occurred in the period from 1993-1994.

SOMPER'S FURS in Beverly Hills: slogans were spraypainted in back of the store saying, "FUR IS DEAD; and "FUR IS MURDER" as well as "WEAR YOUR OWN SKIN." Front and back locks were glued. The ALF left its calling card. They were targeted twice.

THE RED LOBSTER in Studio City had slogans spraypainted on its walls, and had its locks glued. They were hit

twice. The action was tagged "ALF."

WOODLAND HILLS FURRIERS and FASHION FURS in Woodland Hills were spray-painted with slogans "FUR IS DEAD," "FUR IS MURDER," and "FUR BLEEDS." Their locks were glued. The latest action was tagged "PAINT PANTHERS" and pressed-released, appearing on Channel 5 News at 10:00 P.M. and 1:00 A.M. These two stores have been hit about nine times all told. The previous eight actions were tagged "ALF."

HONEYBAKED HAMS in Calabasas had its front windows blown out with explosives as well as its locks glued. The action

was tagged "ALF."

THE LEATHER FACTORY in Van Nuys was spray-painted with the slogan 'WEAR YOUR OWN SKIN" and had its locks glued. The action was signed, "ALF." They were targeted twice.

WINNICKS FURS in SHERMAN OAKS was spray-painted with a variety of slogans pertaining to the subject, and had its locks glued. After three hits, they changed their product line to women's clothing. It has recently come to the attention of the ALF that they are once again selling furs. "ALF" was credited.

BURGER KING in Reseda had slogans painted saying "MEAT STINKS" and MEAT IS MURDER," as well as a message regarding their policy of clearcutting rainforest acreage. Their locks were glued. Courtesy of ALF.

ANGELO'S ITALIAN RESTAURANT in Chatsworth had "VEAL IS CHILD ABUSE" and "VEAL IS MURDER" spray-painted on its walls, and its locks glued. They were targeted twice. ALF.

VITELLO'S ITALIAN RESTAURANT in Encino had "NO VEAL THIS MEAL" spray-painted on its walls and its locks glued.

TANDY LEATHER in Reseda had appropriate slogans spray-painted on its walls and windows, and had its locks glued. The ALF took credit.

MR. KOSHER MEATS in Sherman Oaks had "MEAT STINKS"

and "MEAT IS MURDER" spray-painted on its walls and had its locks glued. They were hit three times. The action was tagged "ALF."

TACO BELL in Tarzana was spray-painted "MEAT STINKS" and "MEAT IS MURDER" and had its locks glued. The ALF took credit.

A veal restaurant had its front window smashed. We cannot supply the name and location of this action for security reasons.

CAFE RENI's in Santa Monica, which serves veal, had "VEAL IS CHILD ABUSE" spray-painted all over its walls, and had its locks glued. The action was tagged "ALF." They were hit twice.

A building owned by Procter & Gamble was spraypainted with slogans saying "ANIMAL ASSASSINS" and "ANI-MAL TORTURERS" and had its locks glued. The city cannot be mentioned for security reasons. ALF.

BURGER KING had its walls spray-painted with the slogans "RAINFOREST RAZERS" and "BOVINE BUTCHERS" and had its locks glued. The ALF took credit.

A "B" dealer had his walls, gates, and driveway spraypainted; the ALF took credit. The city cannot be stated for security reasons.

A store selling hunting equipment in Reseda had its walls spray-painted "ANIMAL ASSASSINS" and had its locks glued. They were hit twice. The ALF took credit.

A sheepskin store in Woodland Hills had its locks glued twice. No painting or tagging was done, as the business is located on a main boulevard.

A McDonald's billboard in Santa Cruz was altered to read, "Over One Billion Slaughtered" and tagged "ALF."


A fur store in the New York garment district had its front windows smashed with the aid of a projectile brick. Under the circumstances, the activist thought it prudent to exit the premises immediately, and no painting or tagging was done.

A vivisector in the Playa Del Rey area had animal rights bumper stickers placed on his car. Not a particularly severe action, but one that hopefully embarrassed him, as he would have had to drive to "work" with A.R. messages visible to his psychotic colleagues. No official credit was taken as such.

We hope the above will serve to let you know that the ALF is active in Southern California. We extend our greetings and gratitude to all activists fighting for the rights of animals. In a world where those in power will literally do anything for a buck, torturing and murdering animals, destroying the planet, and thereby harming humans as well, we do what little we can to make their demonic agendas more difficult to execute.

## ADVANCED

In response to the reader who was unable to locate traplines based on advice in "Ecodefense" (ed. note: see box on bottom corner of next page), it is possible that there were simply no traps in their area at the time they searched. The key to finding traps is to understand how the trapper operates, to "think" like a trapper. Equally critical is a knowledge of the area you are working. You must know the busy roads, the back roads, the snowmobile trails, and how they are used by locals in the trapping season. Know where the target species travel by looking for their tracks in loose dirt, streamside mud or fresh snow.

Trappers are usually highly mobile and will trap an area for a week or two before moving on to another location. Their goal is to "trap out" the available animals and then find a new source of blood money. If the number of catches drops off, or fails to materialize at all, the traps are pulled out and moved elsewhere.

A good time to start trap hunting is in the early weeks of the trapping season (see your state regulations) when trappers are competing with one another for the easy pickings. Another surge in trapping often occurs in late winter/early spring when the mating urge increases travel among target species, especially solitaries like cats, making them vulnerable to trapping even in areas that were trapped out earlier in the season.

As mentioned in *Ecodefense* most trappers are part-timers, working their trapping in around their other obligations (like a job or school.) This means that they are most likely to be traveling their trapline early or late in the day. Others are only seasonally employed and trapping is their winter "job." Mornings are favored by some to reduce the chance of losing an overnight catch to a "trap thief," who is usually another trapper. Checking back roads, jeep trails, and other likely access routes after

an overnight snow may reveal a trapper's tire tracks left in the early hours. Still others may work their trapline after getting off work later in the day.

You can monitor a number of back roads by carefully brushing out a narrow strip of old tire tracks and waiting for fresh tracks to appear on top of the smoothed soil or snow, indicating recent use. To do this, pick a spot near where the road leaves a major traveled route--aided, if necessary, by a landmark alongside the road that you can remember, such as a rock, bush or tree. Adjacent to this, brush smooth a narrow (3-6 inch) strip across either the left or right hand set of tire tracks. Don't brush a wide swath or brush out tracks all the way across the road as this is both unnecssary and much too noticeable. Don't leave obvious scrape marks to reveal what you've done. A daily check, such as a drive-by, will reveal fresh tracks at a glance that may lead you to a trapline. By erasing the fresh tracks you find, you can determine the approximate frequency with which the back road is used. Because trapping regulations usually specify a frequency for trapline checks by the trapper (often 24 or 48 hours-check your copy of the regs), daily or every-otherday use may reveal a trapper at work.

ALWAYS have a rehearsed cover story for being in the area, along with the necessary props. A rifle and small game license can make an acceptable "instant redneck." If you encounter a person or a parked motor vehicle, DON'TSTOP. Memorize the location with the aid of a landmark and keep on going. A friendly wave may be appropriate.

Trappers' vehicles are subject to the abuse of back road driving, and are often older, dirty rattletraps. Pickups are popular because smelly items like rotting bait, odorous lures and animal carcasses can be carried in back along with traps, a shovel, a hammer for driving tap stakes, and assorted

#### HOW TO LEGALLY

At all costs, hunters want to avoid the following:

- 1. Noise
- 2. Scents & odors (gun smoke, human smell, etc.)
- 3. Visibility

Bogus hunters can supply the above three deterrents to successful hunting. First of all, the anti-hunter must look like a hunter, act like a hunter, and talk like a hunter. To make it absolutely legal, it is necessary to secure a hunting license. Then, engage in the following tactics:

- 1. Have some common type of flagrant, bright colored piece of clothing (hat, vest, etc.)
- Plot your area of coverage and travel in pairs (cover as much of a hunting area as possible).
- 3. Get a safe shooting shotgun & use high power shells -- they make more noise.
- 4. Alternately and periodically shoot into a dead stump or dirt bank (Also, talk & chatter

small accessories. Because most trappers work locally, you should know the license plate letters that are typical in the area you're working so as to keep from being distracted by a visitor who's out from the city.

Finding the actual trap set requires practice and a trapper's knowledge of animal movements. Traplines are set along natural wildlife travel routes. Traps set for coyote and fox favor roads, trails, canyon bottoms, streambeds, and saddles in ridges. Bobcats are usually taken on canyon ledges or rocky ridges. Target species mark their territories with scent posts that favor prominent visual features in the landscape, like solitary trees, isolated stumps and rocks, old bones and dried carcasses, and are similarly favored by trappers. I've found traps beside large rocks overlooking a canyon bottom (for bobcat), underneath a tree that stood out slightly from the edge of a clearing, alongside a tree stump in a meadow, and in the middle of narrow paths paralleling streambeds. Experienced trappers like to set traps under evergreens so that eagles don't spot the trapped animal and "steal" it.

Once the trapper locates a probable area for a trap set, he has to think about getting the animal to place its foot on a small spot of ground where the trap is buried. Some will shoot an animal (sometimes illegal if it's a "game" animal) or place a chunk of an animal carcass in a prominent spot to lure animals to the area. If you see ravens, crows, eagles or hawks circling an area, or taking off on your approach, they may be feeding on such a bait. The trapper Claude Dallas, who murdered two Idaho game wardens, was notorious for killing raptors in traps set alongside this type of bait (and it's usually legal!) Most trappers will make their trap sets nearby, on trails, beneath nearby trees, or near potential scent posts, to catch animals traveling to and

from the bait.

Along animal travel routes, the trapper will look for something to attract a predator. First he'll look at what is naturally there. I've found several traps set at the mouths of small animal burrows. Others were buried in spots where a trail crossed through a narrow passage between shrubs or rocks. An additional attraction may be necessary. An animal bone, even a single vertebra, may draw a hungry and curious animal to the trap. Always popular is a dead animal, like a rabbit or skunk, wired to a low tree limb with one or more traps set immediately below it. A small bundle of feathers hung from a tree and flapping in the breeze is visually attractive, especially for cats.

Often these obvious visual and odor lures are backed up by one or more "blind sets," traps without any attractant nearby, usually set on a trail leading to or from a baited trap set. A smooth spot in the dirt, often with rocks or tree branches set on either side to direct the animal's foot directly onto the trap, are all that reveals these sets.

After finding a likely trapping area, post a lookout or keep an ear cocked for approaching vehicles while trap hunting. It is easy at the point to develop "tunnel vision" and overlook warning sounds and sights.

Before you try to locate the trap, it is important to study the appearance of the spot carefully. It is essential that you restore the area to its original appearance before you leave so that the trapper will not suspect trouble and simply replace the missing trap. To locate the actual trap you can probe the ground with a stout stick, or with your booted foot. The trap will be secured, by chain or wire, to either a stake or a "drag" like a large tree limb designed to hang up in the brush when a trapped animal tries to

flee. The drag must be left exactly as you found it. Stakes can usually be pulled up and disposed of along with the trap. If you can't pull up the stake or cut the trap loose (the multi-purpose Leatherman-type tool is handy!) try bending as many parts of the trap as you can by smashing it with a rock. Then, re-bury it and restore the spot to its original appearance.

Throw all traps and stakes Away where they will be hard to find. NEVER carry anything incriminating out with you. Erase your own tracks as you leave. In snow, I carry a cheap pair of insulated "moon boots" so that only these tracks are left at the scene, and they can be discarded with little loss. An important note about winter tracks: unless you can wipe the tracks away, avoid stepping in mud as these tracks can harden like concrete and last weeks or months. Stepping in snow is usually preferred since melting can distort or destroy them. The local game warden may investigate trap sabotage, and these people are usually reasonably competent trackers. From the standpoint of evidence, good forensic photographing or impressioning of footprints in snow is difficult and the necessary skills are not usually available in rural areas for low priority crimes. Don't be intimidated if law enforcement tells you they found "your" footprints. The evidence may simply be of a similar sole that is of common manufacture (you are, of course, intelligent enough to only buy common discount house brands a size or two different from your normal shoe size!)

Finally, don't trust your memory. Study all the available trapping manuals and trap sabotage material again before you go trap hunting, and NEVER forget your security precautions.

7. Watch for the sitters, i.e. hunters who wait for the drivers to push game toward them. The above will alert the game and make them very wary. It will also cause them to hole up and scatter to safer areas. Oh, I know! It spooks them, but would you rather be spooked a bit or dead? It will work and it is all legal. No warden or law enforcement officer can do a thing about it.

#### PICKING OUR TARGETS: THINKING ABOUT RACISM, CLASSISM AND THE ANIMAL LIB-**ERATION FRONT**

As a Jew, everything I do, including work I have done as an A.L.F. activist, I do as a Jew. As a Jewish animal liberation activist, it turns my stomach to hear of A.L.F. actions against kosher butchers.

I am not saying that Jewish people should be "allowed" to profit from the animal abuse industry. But I would encourage other A.L.F. activists to think very carefully about who to target in their actions.

In "animal rightism and the ideology of the single issue" (ed. note: see next page), the author writes, "...the struggle to relieve animals from cruel exploitation is very political. Each particular aspect (i.e. who owns the land on which hunts devastate the wildlife, who dictates psychological control experiments...who profits from the vast food industries...etc) is intimately linked to our own lives and the problems we face."

There are many potential targets for direct action against animal abuse. I would suggest that it is in the best interests of the animals for A.L.F. activists to choose targets wisely, with attention to maximum impact on the animal abuse industry and some thought to the political ramifications of our actions.

For example, it is relatively easy to glue locks of a small kosher butcher shop. What are the effects of this kind of action, in terms of stopping animal abuse? Well, if you do it enough times you may put the shop out of business. Big deal. Small shops are tiny cogs in the animal abuse industry. We can pick off hundreds of these shops and the industry itself will keep on ticking. What we must strive to do, in my opinion, is strike closer to the heart of the animal abuse industry. In terms of the meat branch of the exploitation industry, let's do our research and find out who are the main suppliers of the animals. Let's work harder on large actions: repeatedly hitting the big players in the industry, instead of carrying out many small actions.

We can see how class can be used by the profiteers as a weapon against change, and how racism and classism intersect, by looking at how the earth-destroyers have manipulated environmental struggles into a "jobs vs the earth" corner. One example of this is in local struggles against industrial forestry, where loggers and "environmentalists" (mostly white and middle/upper-class) have been pitted against each other, while the shareholders and the industry thugs sit comfortably in their plush chairs. Meanwhile, the local indigenous people are tokenized, ignored, or bought off by the environmentalists, government, and/or industry-all with the agenda of minimizing native liberation struggles.

The same perils hold true for the animal liberation movement if we continue to blur the distinctions between those who make a huge proft from animal abuse and those who work in the

industry and make enough money to get by.

There are other ramifications of A.L.F. actions in terms of the impact on the diversity of our movement. I am not crying diversity for any "politically correct" reasons, but because I firmly believe that unless we are a diverse movement, with the variety of skills and experience that diversity brings, we will fail.

When we choose targets such as kosher butchers, we are targeting people who are very used to having to fight desperately in order to survive. Jewish people are some of the most tenacious. skilled fighters and I would seriously think about the ramifications of making Jewish communities into our enemies rather than potential allies.

Non-Jewish people must understand that Jewish food laws have been an important part of Jewish culture, and Jewish resistance to assimilation and genocide, for thousands of years. The Jewish community is NEVER going to accept the demands of non-Jewish animal rights activists. It is up to people within these communities to bring about change.

The willingness of some animal rights activists to ally with

the neo-Nazis (ed. note: see article on next page) shows how prevalent racism still is in our movement. I have seen many other examples of racism in general and anti-Jewish racism in particular within our movement. This serves to alienate Jewish animal rights activists.

I would suggest that any animal liberation activists who are serious about making alliances with Jewish people, without selling out the animals, should think about how to assist Jewish animal liberation activists in taking on the task of changing our communities' abuse of animals. By targeting kosher butchers, you make that change more difficult for us.

I do not mean to belittle the work of other A.L.F. activists, who have risked their freedom to try to make a difference for the animals. But if we are going to successfully end animal exploitation, I believe we must move beyond focussing on our short-term aims of ending the suffering of individual animals and look at longterm strategy, which includes examinations of how racism and classism affect our ability to put the animal abuse industry out of business.

#### FOOD FOR US: VEGAN TREATS

This recipe is for my great-grandma, who at 92 still scares the pants off anyone who tries to help in her kitchen. See Bobo, I can be vegetarian and still eat Jewish!

VEGAN KNISHES

from New Farm Vegetarian Cookbook

Dough: Filling: 1 cup cooked potatoes, 1 1/2 cups mashed potatoes peeled & mashed 1/4 tsp. pepper 1/4 cup oil 1/2 tsp. salt 1 tsp. salt 1/2 cup onions, sauteed in 3 cups flour 1/4 cup margarine

1 tsp. baking powder 1/2 cup cold water

Dough: Mix potatoes, oil, and salt. In a separate bowl, mix the flour and baking powder and add to the potato mix. Mix together thoroughly. Make a well in the center and add the water. Knead into smooth dough; place on a lightly floured board and cover with a bowl or cloth and let it rest for 1/2 hour.

Filling: Combine all ingredients and mix well.

To make the knishes: Cut dough into 4 sections. Roll each section out as thin as possible. Cut into 4" x 6" rectangles for nice big knishes, smaller for appetizers. Place some filling in the center of each rectangle and fold the two shorter ends toward the centre, then fold the longer ends over to make a double-folded dumpling. Bake on a welloiled baking sheet, fold side down, at 350 F for about 1/2 hour (until golden).

Serve with tofu sour cream.

### animal rightism and the ideology of the single issue

reprinted from "as long as there are slaughterhouses...then there shall be battlefields.", 1991.

What single issue politics does is attend to 'symptoms' but not attack the disease itself. It presents such issues as if they are aberrations or faults in the system. In reality such problems are the inevitable consequence of a social order based on exploitation and hierarchical power.

The animal rights movement has unfortunately become a single issue. Rather than extend its disgust with the way non-human species are treated in this society to a criticism of this society itself, the movement tends to disappear up its own arse and wallows in its own cliquey issues. Rarely do the 'voices' of the animal rights movement speak about anything other than animal rights, almost as if nothing else existed...but it does.

"there is an undercurrent of misanthropy in the movement; the idea that all people are evil and if only they could be done away with in some way everything would be alright" - P. Gravett, Arkangel #5.

The fact is that the animal liberation movement is made up of human beings and we can't get away from that. Issues relating to OUR lives are important to us, as individuals, yet somehow the movement presents the image that the only true struggle is that for animal rights. Somewhere down the line the animal rights movement has lost its critical tongue, it has ceased to analyse society. Any critical look at society would show that all of the issues are linked together, that the thread of exploitation spins a web in which we are all trapped.

Just like our lives, the struggle to relieve animals from cruel exploitation is very political. Each particular aspect (i.e. who owns the land on which hunts devastate the wildlife, who dictates psychological control experiments (tested on animals before being applied to humans), who profits from the vast food industries, who decides to mount the huge surveilance operations etc, etc) is intimately linked to our own lives and the problems we face. There is a huge political system out there, which perpetuates the abuse of animals, the wholescale destruction of the environment and our own enslavement into lives dulled by work and alienation, because to do so is profitable for a small class of people.

However, some people have forgotten this:

"What reason for living do ordinary, unenlightened people have, dragging out their tiny meaningless lives, changing nothing, achieving nothing, merely taking up space in an already grossly overcrowded world? As I look out of the window of a train, gazing down on a town or a city, and see all the rows and rows of houses stretching into the distance my mind recoils in horror with the thought, "How can they stand to live?", "How can there be enough within their lives to make it worth the effort." - Ronnie Lee, Arkangel #5

The notion of a passive and guilty public - of public opinion as if it were something real and concrete is becoming worryingly prevalent. Individuals struggling for a better world often become bitter and cynical, suggesting that "ordinary people" really do believe everything that is said to them by the media - as if they don't think or talk about it. Often individuals involved in the animal liberation movement talk about the public as if it were an abstract thing not a vast collection of individuals, each capable of thought and subjective opinion.

Because the public is *seen* or *perceived* to be not listening or changing, a contemptuous attitude emerges in which ordinary people are condemned as being non-thinkers, passive or ignorant. "Ordinary" people even become the enemy to some people.

This is undoubtably one of the main reasons why working clas people are so under represented, and why the animal rights movement hasn't developed even the vaguest hint of class analysis.

The fact that the media tends to be the key information source in society, that it is perpetuating the status quo (and that most definitely includes animal abuse), and that it is but one of a whole host of factors playing upon every individual cannot be just conveniently ignored.

Society makes life a bit easier if individuals appear to be inconsiderate, passive or naive. Most people have little control over events in their lives and all around images and information is displayed re-enforcing this notion.

Single issue campaigns fragment the struggle for a sane, free world by containing each problem within its own isolated campaign. Dedication to the campaign is what is required. To concentrate energy - which might otherwise be expended in activities which would really change society - into campaigns for specific issues. Once confronted with concrete, moderate and "realistic" demands, the state can grant them, partially grant them or stall them indefinately. (The long awaited ban on hunting with hounds being a clear example)

It's unfortunate that even the most ardent and sussed activsts can become sucked into the all pervasive single issue ideology of it all; even to such an extent that people who should know better, accept the idea of petitions to the government or the European parliament or consumer boycotts. Animal rights campaigners excuse such things by saying that they attract people to stalls etc. - maybe so, but in doing so it is just re-inforcing the notion that we have no control - we sign away our control to THEM with petitions. "Someone will sort it out, legislate about it." Really? When?

Even more repulsive is the inclusion of articles by blatantly fascist people in Arkangel (an animal rights magazine) under the pathetic excuse that it has a policy of non-censorship. Fascists are the ultimate censors - you cannot allow freedom of speech to those whose ideology promotes the restriction of freedom of speech. Such scum have latched onto every issue out to try and bolster some support for their archaic cause. Those in the animal rights movement who want unity with fascists and still describe abbattoirs and laboratories as Belsens or Auschwitzes are not only incredulously hypocritical but also dangerous. Some of us won't accept fascists on our streets never mind being allowed a voice in our publications. Fascism is based on hierarchical power and the notion of superiority, in exactly the same way animal abuse is. There can be no unity with authoritarians and as ever the song remains the same "the only good fascist is a dead one". Some of us are not afraid to include the police in this equation.

### those who's revolution only goes half way dig their own graves

The legislation cited as victories by animal rights magazines etc. are no more than token gestures and a whole lot less than half measures. All too often the adaptive flexibility of the economic market and its protecting ideologies in parliament and the media are totally ignored. Since animal abuse is, in the end, about making money supported by the idea that animals are ours to do with as we please - by ignoring and avoiding criticising the market we are going nowhere.

Capitalism is the totalitarianism of economics over life. All life becomes a commodity in this society. That's what animals have been reduced to, that is what the majority of people in the world have become. How long are we going to waste all our compassionate anger quibbling about the small details? For animals and ourselves liberation must be total or it will be nothing.

One of the ways the actions going under the name of the a.l.f. are so crucial is that they demonstrate by example that we need not be passive, that we need not have our struggles fought by representatives and that there are ways in which everyone can, quite easily, act against the enemies and cause them considerable damage.

## ASSORTED

#### SEA SHEPHERD SHIP ATTACKED

On July 6, at approximately 8 a.m. Norway time, Norwegian naval or coast guard vessels escorted by helicopters attacked and severely damaged the Sea Shepherd flagship Whales Forever. When attacked, the Whales Forever was in the North Sea en route to attempt to disrupt the Norwegian commercial whaling plans to kill 189 minke whales in 1994 (in defiance of the international whaling moratorium imposed in 1986 by the International Whaling Commission).

According to a Sea Shepherd spokesperson, the Norwegian vessels detonated two depth charges close to the Whales Forever while a pair of minke whales were in the area. The Norwegian ships then rammed the Whales Forever and tried to foul the propellor by dragging a heavy chain beneath the ship. The Whales Forever sustained heavy damage to the bow and is reportedly limping toward the Shetland Islands of Scotland.

The Whales Forever carries an international volunteer crew of 37, including Captain Paul Watson and Lisa DiStefano, who were both convicted in absentia on June 3 for their part in the January 1994 scuttling at dockside of a Norwegian whaler, The Senet, which is again hunting whales in the North Sea.

#### ALASKA WOLF KILL BODY COUNT

Alaska Department of Fish and Game (ADF&G) has announced the results of the first season of a three-year state-funded wolf kill. From October to April, state-hired trappers killed 98 wolves in a 4,000-square-mile area just south of Fairbanks. ADF&G killed the wolves by placing bait in known wolf habitat, then saturating the areas around the bait with traps and snares. Predictably, these curtains of death netted more than just wolves; 13 foxes, 12 moose, 6 coyotes, 2 caribou, 1 snowshoe hare, 1 wolverine, a number of snow geese, and at least 4 golden eagles were also victims. With its typical convoluted logic, ADF&G blames the "incidental" killing of nontarget species on wildlife activists. Their theory is that if environmentalists hadn't raised such a fuss about their plans to gun wolves from helicopters, they could have been more efficient.

Private trappers and hunters had already killed at least 37 wolves in the same area, but were permitted to continue the killing until April 30. State officials believe that the final body count "will be near the original harvest goal of 150 wolves." Harvest?

#### MARINE MAMMAL DE-STRUCTION ACT PASSED

On June 8, USA President Bill Clinton signed a weakened "Marine Mammal Protection Act" (MMPA). The original intent of the act was to protect whales, dolphins, seals, polar bears, and other aquatic mammals killed and injured as a result of commercial fishing and other human activity. There has been intense debate over this bill, with commercial fishing interests pushing to make the MMPA more relaxed about killing marine mammals and environmentalists, animal rights activists, and people who depend on marine mammals for their businesses (eg. whale watchers) pushing for stronger protection for marine mammals.

Recently this act was up for renewal, and in the negotiations that followed an amendment known as the "Polar Bear Amendment" was added to the act. The Polar Bear Ammendment lifts the prohibition on the import of polar bear pelts to the US by hunters who kill them in Canada and Russia. Canada allows about 50 bears to be killed for sport each year.

This totally compromised version of the MMPA, dubbed "The Marine Mammal Destruction Act" by marine mammal protection groups, was supported by a number of environmental groups, including the National Wildlife Federation, National Audubon Society, World Wildlife Fund, and Greenpeace.

#### KOALAS FACE EXTINCTION

The koala, one of the most adored and recognizable animals in the world, may become extinct throughout much of its range in Australia by the turn of the century. Though the koala has survived for 25 million years, the species will soon be wiped out if the Australian government continues to allow logging and land clearing for agriculture and development to eliminate koala habitat areas. Though once wide-spread throughout eastern Australia, today the koala's range is restricted to isolated and fragmented habitat patches primarily in Queensland, New South Wales and Victoria.

On May 3, an Endangered Species Act petition was filed with the US Fish and Wildlife Service (USFWS) requesting an endangered listing for the koala in Victoria and New South Wales and a threatened listing for the species in Queensland. The listing will have the immediate effect of making it unlawful to import koalas into the US without USFWS approval. Conservationists also anticipate that a listing for the

koala under US law will put pressure on the Australian wildlife authorities to take steps to immediately protect the koala and its habitat. Over 40 Australian and US conservation and animal protection organizations have endorsed the petition.

The petition provides a detailed discussion of habitat destruction in Australia, koala diseases, and other factors, such as fire, automobiles, and dogs, that threaten the koala.

## MUTTERINGS

#### PMU: A NIGHTMARE FOR HORSES AND HUMANS

#### THE DRUG

PMU are the initials for pregnant mare urine. PMU is also something that is used to produce the drug premarin. Premarin is an estrogen substitute taken from the urine of pregnant mares and prescribed to alleviate menopausal symptoms. Over eight million women now take the drug and Ayerst Organics (the Canadian-owned exclusive producer of premarin) is raking in the money made from misery. Ayerst's parent company is American home products/Whitehall Laboratories, manufacturer of Dristan, Advil, Chef Boyardee and many other products.

#### THE PROCESS

To produce the drug, mares are impregnated, then fitted to a hose to collect the urine. The mares are not allowed out to pasture because this would mean losing urine; they are forced to remain in stalls 8 feet long and 4 to 5 feet wide for their eleven month pregnancy. After giving birth, the mares are allowed only two months foals with their and then reimpregnated, and back on the production line. The foals are usually sold to be slaughtered and used for meat, for dog food, and also human consumption.

#### THE OUTRAGE CONTIN-UES

In 1993, an estimated 75,000 mares on 458 farms throughout Canada and North Dakota were confirmed for urine collection, giving birth to as many as 90,000 foals (all to be "destroyed"). Ayerst is preparing for a \$100 million expansion of its facilities in Manitoba with the aid of \$20 million from the Canadian government.


#### THE ALTERNATIVES



Armaments: Handguns, shotguns, assault rifles, tear-gas rifles, billy clubs, shields, bullet-proof armor, helmets and face-shields.


Demeanor: Surly and hostile or aggressively friendly
